MERGER AGREEMENT

between

"AIK BANKA" A.D. BEOGRAD as the Acquiring Bank

and

EUROBANK DIREKTNA A.D. as the Transferring Bank

In Belgrade, on [●] [●] 2025

This Merger Agreement ("**Agreement**") has been concluded in Belgrade on [●] [●] 2025 by and between

- (1) Agroindustrijsko komercijalna banka "AIK Banka" akcionarsko društvo, Beograd, a joint-stock company with registered office at 115d Mihaila Pupina Boulevard, Belgrade New Belgrade, registered in the Business Registers Agency under registration number 06876366, TIN 100618836, which operates on the basis of a licence issued by the National Bank of Yugoslavia in its Decision O. No. 194 of 28 June 1993, represented by Petar Jovanović, Chairperson of the Executive Board (hereinafter: "Acquiring Bank"); and
- (2) **Eurobank Direktna akcionarsko društvo Beograd**, a joint-stock company with its registered office at 10 Vuka Karadžića Street, Belgrade, registered in the Business Registers Agency under registration number 17171178, TIN 100002532, which operates on the basis of a licence issued by the National Bank of Yugoslavia in its Decision G No. 633 of 21 October 1997, represented by Slavica Pavlović, Chairperson of the Executive Board (hereinafter: "**Transferor Bank**")

(The Acquiring Bank and the Transferor Bank shall hereinafter collectively be referred to as the "Contracting Parties" or "Merger Participants").

Whereas:

- (A) the Acquiring Bank is a joint-stock company that is not considered a public joint-stock company in terms of the Law on Companies;
- (B) the Transferor Bank is a joint-stock company that is not considered a public joint-stock company in terms of the Law on Companies;
- (C) the Board of Directors of the Acquiring Bank on 21 October 2024 made decisions to adopt this draft Agreement and draft decisions to accept merger and amendments to the Memorandum of Association of the Acquiring Bank;
- (D) the Board of Directors of the Transferor Bank on 21 October 2024 made a decision to adopt this draft Agreement and draft decision on merger;
- (E) pursuant to Article 490, Paragraphs 4, 5 and 6 of the Law on Companies, all shareholders of the Contracting Parties agreed not to prepare reports in terms of Article 490, Paragraph 1, Items 2, 3, and 4;
- (F) the Contracting Parties, pursuant to Article 495, Paragraph 1 of the Law on Companies fulfilled the obligation to publish this draft Agreement;
- (G) the Assembly of the Transferor Bank on [●] [●] 2024 adopted the decision on merger and the decision approving this draft Agreement;
- (H) the Assembly of the Acquiring Bank on [●] [●] 2024 made decisions to: (i) accept the merger,
 (ii) approve this draft Agreement and (iii) approve the amendments to the Memorandum of Association of the Acquiring Bank;
- (I) the realisation of the status change of the merger pursuant to this Agreement is conditional upon prior consent of the National Bank of Serbia as prescribed by Article 133 of the Law on Banks;

- (J) the Contracting Parties wish to implement the merger of the Transferor Bank with the Acquiring Bank in accordance with the terms and conditions of this Agreement;
- (K) an integral part of this Agreement consists of:
 - Annex 1 Draft Decision on Amendments to the Memorandum of Association of the Acquiring Bank;
 - Annex 2 Description and data on the value of assets and liabilities of the Transferor Bank as of 30 September 2024, to be transferred to the Acquiring Bank through this Merger;
 - Annex 3 List of registered and non-registered immovable properties owned by the Transferor Bank:
 - Annex 4 List of vehicles owned by the Transferor Bank; and
 - Annex 5 List of employees in the Transferor Bank whose employment continues in the Acquiring Bank.

The Contracting Parties have agreed as follows:

1. SUBJECT OF THE AGREEMENT

The subject of this Agreement is the implementation of the status change of the merger of the Transferor Bank with the Acquiring Bank, whereby the Transferor Bank transfers all of its assets, rights and liabilities to the Acquiring Bank and ceases to exist without liquidation, while the entire assets, rights and liabilities of the Transferor Bank shall be transferred to the Acquiring Bank as the universal legal successor of the Transferor Bank, and the Acquiring Bank continues to operate under its business name, in its registered office and to perform the same activity (hereinafter: "Merger").

2. THE GOAL AND TERMS OF THE MERGER

- 2.1 Bearing in mind that the Acquiring Bank is the owner of 100% of the shares of the Transferor Bank, and that both Contracting Parties are banks operating in accordance with the regulations of the Republic of Serbia, the Merger is carried out for the purpose of:
 - (i) business rationalisation;
 - (ii) increase in market share on the banking market of Serbia:
 - (iii) formation of a long-term business strategy;
 - (iv) expansion of the business network of both Banks' clients and possible new clients who will get an integrated offer of all banking products and a greater possibility to finance their development programmes;
 - (v) optimisation and centralisation of management and administrative tasks;
 - (vi) higher quality and more efficient work processes, work control and improvement of corporate management;
 - (vii) comprehensive improvement of the overall business in terms of cost-effectiveness and profitability.
- 2.2 Realisation of the Merger based on this Agreement is conditional on the consent of the National Bank of Serbia pursuant to Article 133 of the Law on Banks.
- 2.3 No special terms of the Merger shall be agreed upon, except those expressly provided for in this Agreement.

3. AGREED MERGER DATE AND MERGER REGISTRATION DATE

- 3.1 The agreed Merger date in terms of Item 45 of the Decision on Implementing the Provisions of the Law on Banks Relating to Granting of a Preliminary Bank Founding Permit, Bank Operating Licence and Consents and Approvals by the National Bank of Serbia is 30 September 2024 (hereinafter: "Agreed Merger Date").
- 3.2 The date of Merger registration in the Business Entities Register of the Business Registers Agency (hereinafter: "Business Entities Register") is the day when the Transferor Bank's business activities cease and the day when the legal consequences of the status change prescribed in Article 505 of the Law on Companies begin (hereinafter: "Merger Registration Date").
- 3.3 Pursuant to Article 491, Paragraph 2, Item 6 of the of the Law on Companies, Merger Registration Date is the date on which all business transactions of the Transferor Bank will be considered for accounting purposes as transactions carried out on behalf of the Acquiring Bank.

4. ASSETS AND LIABILITIES OF THE TRANSFEROR BANK TO BE TRANSFERRED TO THE ACQUIRING BANK THROUGH THE MERGER

- 4.1 Description of assets and liabilities of the Transferor Bank that are transferred to the Acquiring Bank by the status change of the Merger on the basis of this Agreement, as well as data on their book value as of 30 September 2024 are given in Annex 2 of this Agreement. In case of need or at the request of the competent authority, the Contracting Parties may make amendments to Annex 2 of this Agreement until the Merger Registration Date.
- 4.2 This Agreement represents the basis for the transfer of all assets and liabilities of the Transferor Bank to the Acquiring Bank in accordance with the law.

5. METHOD OF TRANSFER OF ASSETS AND LIABILITIES

- 5.1 The entire assets and liabilities of the Transferor Bank are transferred to the Acquiring Bank as the universal legal successor of the Transferor Bank on the Merger Registration Date, as follows:
 - all funds of the Transferor Bank in current and other accounts with the National Bank of Serbia and/or other banks in the country and abroad will be transferred to the business accounts of the Acquiring Bank with the National Bank of Serbia and/or other banks in the country and abroad;
 - (ii) all the rights of the Transferor Bank to the registered and non-registered immovable properties listed in Annex 3 of this Agreement are transferred to the Acquiring Bank, without exception or limitation, and the Acquiring Bank is authorised to register in the competent real estate cadastres and other public registers of immovable property, on all immovable properties on which the Transferor has a certain right, the corresponding rights in favour of the Acquiring Bank, without any further consent or presence of the Transferor Bank and the Transferor Bank agrees on that ("clausula intabulandi");
 - (iii) the right of ownership of the vehicles listed in Annex 4 of this Agreement, as well as movable property, fixed assets, equipment, small inventory, etc., is transferred to the Acquiring Bank based on the accounting balance on the Merger Registration Date, in accordance with this Agreement, and the Transferor Bank agrees that, where applicable, the Acquiring Bank is registered in the competent public registers and/or with the competent authorities as the owner of the same without its further consent and participation;
 - (iv) all rights, liabilities, responsibilities and benefits from the contract concluded by the Transferor Bank and which have not been fully executed are transferred to the Acquiring Bank, which takes the place of the Transferor Bank, unless something else has been agreed upon;

- (v) all the rights and obligations of the Transferor Bank from received and given collateral such as mortgages, pledges, bank guarantees, warranties, letters of credit, letters of support, promissory notes, drafts, insurance policy bonds and other collateral of any kind, as well as rights and obligations from the concluded insurance contracts are transferred to the Acquiring Bank on the basis of this Agreement;
- (vi) the right of ownership of the securities owned by the Transferor Bank is transferred to the Acquiring Bank;
- (vii) all intellectual property rights, copyrights and related rights, licences, certificates, permits and all other rights given or assigned to the Transferor Bank are transferred to the Acquiring Bank on the Merger Registration Date in the manner provided for the transfer of the corresponding type of rights, unless otherwise provided by law;
- (viii) debts and other obligations of the Transferor Bank towards any third party, including, but not limited to, creditors and co-contractors from contracts concluded by the Transferor Bank, as well as all tax obligations of the Transferor Bank are transferred to the Acquiring Bank by force of law on the Merger Registration Date.
- 5.2 For the avoidance of doubt, the entire property of the Transferor Bank (including property not explicitly mentioned in this Agreement), all property rights, rights of ownership and use, other real rights, judicial and other proceedings, all claims and all debts, obligations and liabilities of the Transferor Bank towards any third party will be transferred to the Acquiring Bank on the Merger Registration Date.
- 5.3 The Acquiring Bank acquires things and rights that are acquired by registration in the public books, i.e. by obtaining certain consents or approvals, by registration in the corresponding public books, i.e. by obtaining those consents or approvals. In the event that it is necessary to obtain certain consents or approvals from third parties for the transfer of rights under one of the contracts concluded by the Transferor Bank, and until such consents or approvals are obtained, it will be considered that all rights and claims based on such contract have been assigned to the Acquiring Bank in accordance with Article 436 of the Law on Contract and Torts.
- 5.4 With regard to all things and rights whose transfer is conditioned by entry in public books, registers or records maintained by competent authorities such as, without limitation, the National Bank of Serbia, the Central Securities Depository and Clearing House, the Real Estate Cadastre, registers maintained with the Business Registers Agency, the Intellectual Property Office and the Ministry of Internal Affairs, the Transferor Bank gives irrevocable consent that the Acquiring Bank may, on the basis of this Agreement, without any further consent and approval, register, transfer and/or record for its own benefit and in its own name, all such rights of the Transferor Bank before the aforementioned and all other competent authorities that maintain such public books, registers and records.
- 5.5 All mutual claims between the Transferor Bank and the Acquiring Bank cease to exist on the Merger Registration Date.

6. CAPITAL AND SHARES

6.1 Bearing in mind that the Acquiring Bank is the sole shareholder and direct owner of 100% of the Transferor Bank's shares, i.e. that the Merger represents a merger with a controlling company in terms of the Law on Companies (a) no cash payments shall be made, (b) the Acquiring Bank's share capital shall not increase, (c) there shall be no need for the exchange of shares, i.e. definition of the data for the exchange of shares, and (d) the ownership structure of the Acquiring Bank's shares shall remain the same after the Merger Registration Date, without any changes in the Merger procedure.

6.2 On the Merger Registration Date, all 119,815 ordinary shares with a nominal value of 100,000.00 dinars per share issued by the Transferor Bank will be cancelled and the procedure for their deletion from the Central Securities Depository and Clearing House will be carried out in accordance with the law.

7. BOARDS OF DIRECTORS AND EXECUTIVE BOARDS OF THE CONTRACTING PARTIES

- 7.1 All offices of members of the Executive Board and Board of Directors and registered representatives of the Transferor Bank shall cease on the Merger Registration Date.
- 7.2 None of the members of the Executive Board and/or Board of Directors of any Contracting Party shall acquire the right to a bonus, other benefit or right in connection with a status change that is foreseen by this Agreement.

8. EMPLOYMENT – RIGHTS OF EMPLOYEES IN THE TRANSFEROR BANK

- 8.1 The Acquiring Bank shall take over all valid employment agreements of employees who, on the Merger Registration Date, are employed in the Transferor Bank. List of employees in the Transferor Bank as of 30 September 2024 is given in Annex 5 of the Agreement and forms its integral part. For the avoidance of any doubt, the Contracting Parties agree that the Acquiring Bank shall take over only those employees who are employed by the Transferor Bank, i.e. who have valid employment agreements with the Transferor Bank on the Merger Registration Date, regardless of the list in Annex 5.
- 8.2 The Transferor Bank shall fully and truthfully inform the Acquiring Bank about the rights and obligations in the general act, i.e. the collective agreement/work rulebook and the employment agreements to be transferred.
- 8.3 Pursuant to the Labour Law, the Acquiring Bank shall take over from the Transferor Bank the general act, i.e. collective agreement, i.e. the work rulebook valid on the Merger Registration Date.
- 8.4 Pursuant to Article 149, Paragraph 1 of the Labour Law, the Transferor Bank shall inform the employees whose employment agreement is being transferred in writing about the transfer of the employment agreement to the Acquiring Bank.
 - If the employee refuses the transfer of the employment agreement in terms of the previous paragraph, the Transferor Bank may cancel the employee's employment agreement.
- 8.5 After the merger, the employees of the Transferor Bank shall continue to work in the Acquiring Bank in the same or other appropriate job positions in accordance with the Rulebook on Internal Organisation and the Rulebook on Job Systematisation in the Acquiring Bank.
- 8.6 The general act of the Transferor Bank, i.e. the collective agreement/work rulebook, shall apply to the other rights of the employees of the Transferor Bank, within a period of one year from the date of registration of the status change, unless before the expiry of that period:
 - the time for which the general act, i.e. collective agreement/work rulebook concluded with the Transferor Bank as the predecessor employer expires;
 - a new general act, i.e. collective agreement/work rulebook, is concluded with the Acquiring Bank as the follower employer.

8.7 Pursuant to Article 151 of the Labour Law, the Acquiring Bank and the Transferor Bank shall at least 15 days before the change of employer inform the representative trade union of the employer about the date or proposed date of the change of employer, the reasons for the change of employer, as well as the legal, economic and social effects of a change of employer on the position of employees and measures to mitigate them. If the employer does not have a representative trade union, employees have the right to be immediately informed of the aforementioned circumstances, through a notice on the employer's internal portal.

9. LEGAL EFFECTS OF THE MERGER

The Merger Registration Date shall bring the following legal effects:

- (i) the entire assets and liabilities of the Transferor Bank shall be transferred to the Acquiring Bank as the universal legal successor of the Transferor Bank;
- (ii) The Transferor Bank shall cease to exist without conducting the liquidation procedure;
- (iii) all 119,815 ordinary shares (ISIN and (CFI)) RSEFGEE18631 (ESVUFR), of nominal value 100,000.00 dinars per share issued by the Transferor Bank, shall be cancelled;
- (iv) all permits, concessions, other privileges and exemptions granted or recognised to the Transferor Bank shall be transferred to the Acquiring Bank in accordance with this Agreement, unless the regulations governing their granting specify otherwise;
- (v) all mutual claims between the Transferor Bank and the Acquiring Bank cease to exist; and
- (vi) all members of the Executive Board and Board of Directors of the Transferor Bank and representatives of the Transferor Bank shall have their term terminated, as well as all duties and powers in the Transferor Bank.

10. PUBLICATION AND NOTICES

- 10.1 The draft of this Merger Agreement shall be published in accordance with the Law on Companies on the Business Registers Agency's website and the Transferor Bank's and the Acquiring Bank's websites no later than 60 days before the Merger approval date by the Contracting Parties' shareholders' assembly.
- 10.2 The Acquiring Bank and the Transferor Bank confirm that on [●] [●] 2024, their shareholders were informed in writing that they can inspect the acts and documents in terms of Articles 490 and 496 of the Law on Companies, and that they may copy them every working day starting [●] [●] 2024 at the offices of the Acquiring Bank and the Transferor Bank from 9:00 a.m. to 5:00 p.m.
- 10.3 Each Contracting Party guarantees to the other Contracting Party that it has duly notified all significant creditors of the intended Merger. For the purposes of this Article, "significant creditor" is any creditor who, on the date of publication of the draft Merger Agreement, as provided for in Article 10.1, had a claim against the Contracting Party in an amount equal to or greater than 2,000,000.00 dinars in the equivalent of any currency at the middle exchange rate of the National Bank of Serbia on the day of publication of the draft Merger Agreement.
- 10.4 The Transferor Bank's and the Acquiring Bank's creditors are informed by the publication of this draft Agreement of their rights to security, i.e. settlement of claims and the right to report the same within the prescribed period for publication.

11. COURT AND OTHER PROCEEDINGS

The Acquiring Bank shall inform the courts and other authorities before which proceedings are conducted in which the Transferor Bank is a party to the proceedings that the Transferor Bank has ceased to exist, and that in the proceedings, in which this is permitted by the law applicable to the specific proceedings and to the extent in which it is possible, the procedure is continued by the Acquiring Bank.

12. NO REPORTS

The Contracting Parties agree that their shareholders, pursuant to Article 490, Paragraphs 5 and 6 of the Law on Companies, decided not to prepare the following documents up for the purposes of the Merger:

- (a) Financial statements with the opinion of an authorised auditor, otherwise required pursuant to Article 490, Paragraph 1, Item 2 of the Law on Companies;
- (b) Auditor's reports on the status change audit, otherwise required pursuant to Article 490, Paragraph 1, Item 3 of the Law on Companies; and
- (c) Reports of executive boards/boards of directors on status change, otherwise required pursuant to Article 490, Paragraph 1, Item 4 of the Law on Companies.

13. REGISTRATION IN THE BUSINESS ENTITIES REGISTER

The merger participants agree that the following registrations will be made in the Business Entities Register, in accordance with this Agreement and the corresponding decisions regarding the Merger:

- (i) Merger registration;
- (ii) registration of dissolution of the Transferor Bank that ceases to exist by Merger; and
- (iii) registration of amendments to the Memorandum of Association of the Acquiring Bank.

14. TAX RETURNS AND TAXES

Each Contracting Party shall promptly prepare, sign and submit to the competent authorities: (i) all financial and other necessary reports, and (ii) all applications and tax returns, which are required in accordance with the Law on Banks, the Law on Accounting, the Law on Corporate Income Tax, the Law on Value Added Tax and the Law on Tax Procedure and Administration in connection with the Merger.

15. COSTS

- 15.1 Each Party shall bear its own costs in connection with the negotiation, preparation, and implementation of this Agreement and the Merger.
- 15.2 The Acquiring Bank will bear all the costs of fees at the notary public in connection with the signing and certification of this Agreement.

16. GOVERNING LAW

- 16.1 This Agreement and all rights and obligations arising from or in connection with this Agreement shall be governed and interpreted in accordance with the substantive law of the Republic of Serbia.
- 16.2 Any dispute arising from or in connection with this Agreement shall be finally resolved by the Commercial Court in Belgrade.

17. OTHER PROVISIONS

- 17.1 This Agreement shall enter into force after: (i) signing and certification by a notary public, and (ii) obtaining the prior approval of the National Bank of Serbia for the Merger pursuant to Article 133 of the Law on Banks, cumulatively.
- 17.2 Neither Contracting Party shall have the right to assign or transfer any right, claim, liability or contractual position under this Agreement to a third party, without the prior written consent of the other Contracting Party. Any assignment or transfer made contrary to this article will not produce legal effect.
- 17.3 This Agreement constitutes the entire and only agreement between the Parties regarding the Merger and other matters governed by this Agreement.
- 17.4 This Agreement may be amended only by written amendments signed by both Contracting Parties and certified by a notary public.
- 17.5 This Agreement is drawn up in 7 (seven) identical copies, 3 (three) for each Contracting Party and 1 (one) copy for the notary public.

AMENDMENTS TO THE MEMORANDUM OF ASSOCIATION OF AGROINDUSTRIJSKO KOMERCIJALNA BANKA "AIK BANKA" AD BEOGRAD BULEVAR MIHAILA PUPINA 115 Ð, BEOGRAD

Article 1

The title of the MEMORANDUM OF ASSOCIATION OF AGROINDUSTRIJSKO KOMERCIJALNA BANKA "AIK BANKA" AD BEOGRAD, BULEVAR MIHAILA PUPINA 115 D, BEOGRAD shall be amended to read as follows:

"MEMORANDUM OF ASSOCIATION of AikBank ad Beograd"

Article 2

New paragraph 8 shall be added to Article 1, after Paragraph 7, to read as follows:

"By amendments to the Memorandum that entered into force on _ the Memorandum is, inter alia, in compliance with the Decision of the Assembly on the change of the business name and office of the Bank."

The previous Paragraphs 8 and 9 become Paragraphs 9 and 10.

Article 3

Paragraphs 2, 3 and 5 in Article 2 shall be amended to read as follows:

"The Bank registered the transfer in the Business Entities Register managed by the Business Registers Agency on 1 March 2005, with the reference number BD. (in Cyrillic script) 2946/2005 and information about this transfer can be found published on the web page of the Business Registers Agency. The Bank operates under the following name (business name of the Bank is): AikBank akcionarsko društvo Beograd.

For its operations, the Bank may use, under the same conditions and in the same manner in which it uses the business name, in addition to the name referred to in the previous paragraph of this article, the abbreviated business name – an abbreviated name that reads: AikBank ad Beograd.

The Bank's office is in Belgrade (New Belgrade), 59a Arsenija Čarnojevića Boulevard."

Article 4

New paragraph 26 shall be added to Article 4, after Paragraph 25, to read as follows:

"After the implementation of Assembly Decision No. 04-LXVII/2023 on the issuance of the XXV issue of ordinary shares without the obligation to publish a prospectus in order to increase the basic (share) capital,

the share capital referred to in this article amounts to 21,791,680,986.68 dinars, divided into 10,424,447 shares with a nominal value of 1 (one) share of 2,090.44 dinars, of which:

- 9,256,027 are fractions of ordinary shares,
- 1,127,431 are fractions of priority cumulative shares, and
- 40,989 are priority convertible shares."

The previous paragraphs 26-44 become paragraphs 27-45.

In the same article, the previous paragraph 37, which becomes paragraph 38, shall be amended to read as follows:

"The total share capital of "AIK BANKA" a.d. Beograd, with the balance on 30 June 2022 (before the merger of Naša AIK BANKA AD Beograd) was 19,762,595,400.68 RSD, divided into 9,453,797 fractions of shares with the nominal value of 1 (one) share of 2,090,44 RSD, of which 8,285,377 are fractions of ordinary shares, 1,127,431 are fractions of priority cumulative shares and 40,989 are fractions of priority convertible shares. The majority shareholder of the Bank is M&V INVESTMENTS AD BEOGRAD, with 100% ordinary shares (97.578306% in all three classes of shares). The minority shareholders recorded in the unique records of the Central Securities Depository and Clearing House as shareholders of "AIK BANKA" a.d. Beograd are listed in Annex A of the Memorandum of Association that entered into force on 1 December 2022."

In the same article, the previous paragraph 39, which becomes paragraph 40, shall be amended to read as follows:

"The total share capital of "AIK BANKA" a.d. Beograd after the merger, with the balance on 30 June 2022 (agreed date of merger), due to merging Naša AIK BANKA AD BEOGRAD, for its only member of "AIK BANKA" a.d. Beograd, in cash, was 19,762,595,400.68 RSD, divided into 9,453,797 fractions of shares with the nominal value of 1 (one) share of 2,090,44 RSD, of which 8,285,377 fractions of ordinary shares, 1,127,431 fractions of priority cumulative shares and 40,989 fractions of priority convertible shares. The majority shareholder of the Bank is M&V INVESTMENTS AD BEOGRAD with 100% ordinary shares (97.578306% in all three classes of shares). The minority shareholders recorded in the unique records of the Central Securities Depository and Clearing House as shareholders of "AIK BANKA" a.d. Beograd are listed in Annex A of the Memorandum of Association that entered into force on 1 December 2022.

In the same article, the previous paragraph 44, which becomes paragraph 45, shall be amended to read as follows:

"The value of assets and the amount of liabilities of Naša AIK BANKA AD BEOGRAD, according to the balance on 30 June 2022 (in thousands RSD), that are transferred to "AIK BANKA" a.d. After the new paragraph 45, paragraphs 46 to 54 shall added to read as follows:

"AIK BANKA" a.d. Beograd, by registering ownership of shares of Eurobank Direktna akcionarsko društvo Beograd in the Central Securities Depository and Clearing House, acquired the controlling ownership in Eurobank Direktna akcionarsko društvo Beograd on 2 November 2023, which enabled it to acquire 100% voting rights, as well as the acquisition of this company as a dependent company in which the Bank has 100% share capital.

The total share capital of "AIK BANKA" a.d. Beograd, with the balance as of 30 September 2024 (before the merger of Eurobank Direktna akcionarsko društvo Beograd) was 21,791,680,986.68 RSD, divided into 10,424,447 fractions of shares with the nominal value of 1 (one) share of 2,090,44 RSD, of which 9,256,027 fractions of ordinary shares, 1,127,431 fractions of priority cumulative shares and 40,989 fractions of priority convertible shares. The majority shareholder of AIK Banka is M&V INVESTMENTS AD BEOGRAD, registration number 08614938, with 100% ordinary shares with voting rights (97.80380% in all three classes of shares). The minority shareholders recorded in the unique records of the Central Securities Depository and Clearing House as shareholders of "AIK BANKA" a.d. Beograd are listed in Annex A of this Memorandum of Association.

The total share capital of Eurobank Direktna akcionarsko društvo Beograd, with the balance as of 30 September 2024 (before the merger) was 11,981,500,000.00 RSD, divided into 119,815 fractions of shares with the nominal value of 1 (one) share of 100,000.00 RSD. The only shareholder of Eurobank Direktna akcionarsko društvo Beograd is "AIK BANKA" a.d. Beograd.

The total share capital of "AIK BANKA" a.d. Beograd after the merger, with the balance on 30 September 2024 (agreed date of merger), was 21,791,680,986.68 dinars, divided into 10,424,447 fractions of shares with the nominal value of 1 (one) share of 2,090.44 RSD, of which 9,256,027 fractions of ordinary shares, 1,127,431 fractions of priority cumulative shares and 40,989 fractions of priority convertible shares. The majority shareholder of AIK Banka is M&V INVESTMENTS AD BEOGRAD, registration number 08614938, with 100% ordinary shares with voting rights (97.80380% in all three classes of shares). The minority shareholders recorded in the unique records of the Central Securities Depository and Clearing House as shareholders of "AIK BANKA" a.d. Beograd are listed in Annex A of this Memorandum of Association.

As Eurobank Direktna akcionarsko društvo Beograd is a dependent company, 100% owned by "AIK BANKA" a.d. Beograd, in the process of implementing the status change of the merger of Eurobank Direktna akcionarsko društvo Beograd to "AIK BANKA" a.d. Beograd, there was no change in the share capital of "AIK BANKA" a.d. Beograd. The existing shareholders of "AIK BANKA" a.d. Beograd shall remain the shareholders of "AIK BANKA" a.d. Beograd, without any changes.

In the process of implementing the status change of the merger of Eurobank Direktna akcionarsko društvo Beograd to "AIK BANKA" a.d. Beograd, the cancellation of shares of Eurobank Direktna akcionarsko društvo Beograd from the Central Securities Depository and Clearing House was performed.

"AIK BANKA" a.d. Beograd is the legal successor of all the rights and obligations of Eurobank Direktna akcionarsko društvo Beograd towards third parties as of the date of registration of the Merger with the Business Registers Agency. Eurobank Direktna akcionarsko društvo Beograd shall transfer its entire assets and liabilities to "AIK BANKA" a.d. Beograd by registering the status change in the Serbian Business Registers Agency. The property rights of movable property, real estate, securities, cash and other assets, as well as lien rights of Eurobank Direktna akcionarsko društvo Beograd are transferred to "AIK BANKA" a.d. Beograd by registering the status change in the Serbian Business Registers Agency.

Eurobank Direktna akcionarsko društvo Beograd transfers to "AIK BANKA" a.d. Beograd all liabilities and all its assets, such as the property rights and other rights, including all the receivables and payables, as well as its securities and encumbrances.

The value of assets and the amount of liabilities of Eurobank Direktna akcionarsko društvo Beograd, according to the balance on 30 September 2024 (in thousand RSD), that are transferred to "AIK BANKA" a.d. Beograd due to the status change, is provided in Annex B, which is an integral part of this Memorandum of Association. According to the balance on 30 September 2024, the value of assets of Eurobank Direktna akcionarsko društvo Beograd is 288,156,554 thousand RSD, and the value of total liabilities is 248,051,665 thousand RSD, and the value of total capital is 40,104,889 thousand RSD."

Article 5

Paragraph 1 of Article 28 shall be amended to read as follows:

"In accordance with the Law, the Bank performs the following operations:

- deposit operations (receiving and depositing deposits),
- credit operations (granting and taking loans),
- foreign exchange, foreign currency and exchange operations,
- issuing guarantees and other guarantee forms (guarantee affairs),
- payment transactions,
- payment card issuance,
- purchase, sale and collection of receivables (factoring, forfeiting, assignment of receivables, taking over receivables/debts, replacement of fulfilment, etc.),
- operations with securities (issuing securities, etc.),
- broker-dealer operations,
- insurance representation operations,
- operations related to management of property owned by the Bank (sale, renting, adaptation, building, etc.)
- operations for which it is authorised by the law,

other operations, the nature of which is similar or related to affairs from previous points (financial leasing, etc.), in accordance with the Bank's Memorandum and Articles of Association."

Article 6

Paragraph 1 of Article 43 shall be amended to read as follows:

"This consolidated text of the Memorandum includes the primary text of the Memorandum of 29 September 2006, as well as the amendments to the Memorandum that entered into force on 7 October 2010, on 27 May 2011, on 14 May 2012, on 31 May 2014, and amendments approved by NBS on 19 February 2015 and 10 June 2015, and the Bank Assembly adopted these at the meeting on 29 June 2015 by the majority of the total number of present shareholders with the right to vote. Additionally, the Memorandum includes amendments that the Bank Assembly adopted at the meeting on 23 December 2015 and for which the National Bank of Serbia gave consent on 19 January 2016; amendments that the Bank Assembly adopted at the meeting on 28 April 2017, and for which the National Bank of Serbia gave consent on 25 May 2017; amendments adopted by the Bank Assembly at the meeting held on 20 November 2017 that entered into force upon the consent of the National Bank of Serbia of 21 December 2017; amendments adopted by the Bank Assembly at the meeting held on 17 December 2018, for which the National Bank of Serbia gave its consent on 15 January 2019; and amendments adopted by the Bank Assembly at the meeting held on 14 October 2022, for which the National Bank of

Serbia gave its consent on 17 November 2022, as well as amendments adopted by the Bank Assembly at the held on 2024, for which the National Bank of Serbia gave its consent on ."

Article 7
